**IMPORTANT DEADLINE DATES:**

- **Friday, March 20<sup>th</sup>** – Individual client tax documents due to Benefield & Hamner, CPA's  
**We cannot guarantee your return will be complete by the deadline if the majority of your documents are received after this date.**
- **Wednesday, April 1<sup>st</sup>** – Individual client tax extension info and/or extension payments (check or bank draft) due to Benefield & Hamner, CPA's  
**If we have not received communication from you by this date, as a courtesy, we will prepare and file an automatic extension on your behalf. Please note, payments will not be remitted with this courtesy automatic extension.**
- **Wednesday, April 15<sup>th</sup>** – IRS individual filing deadline

If you provide copies of any tax-related documents (W-2's, other income, deductions, etc.) electronically we request that they are uploaded to the secure client portal as a PDF and not as an image/picture.

**2025 TAX ORGANIZER**

If requested, be on the lookout in mid-January for your personalized 2025 tax organizer.

**The following are common issues that sometimes are not clearly communicated, so please be sure to pay attention to the following:**

**We must have your original (or a clean PDF) of income source documents (W-2, Retirement, Social Security, investment income). Pictures of documents are difficult to read and print, therefore we require that they be sent as a PDF and not as an image (JPEG, PNG, WebP, etc.).**

**Also, please provide us with all sets of your W-2's and 1099's, including the "Employee Copy", since that is the copy that we attach to your printed file copy of the tax returns.**

- If you made any estimated tax payments during the year, please be sure to let us know the dates and the amounts of each payment. Please also provide proof of payment. Some other items to note for 2025 and future tax years are as follows:
  - Both the IRS and the state of Alabama have established websites that greatly facilitate taxpayer tax payments of any kind, as follows:
    - Federal – [www.EFTPS.gov](http://www.EFTPS.gov)
    - Alabama – <https://myalabamataxes.alabama.gov>
      - (Commonly referred to as My Alabama Taxes)

The use of these websites for tax payments (such as quarterly estimated tax payments, or payment of balance due when the annual tax returns are filed), are NOT required, yet, but they are being heavily encouraged.

- Non-monetary/in kind charitable contributions now have even tougher qualifications and valuation requirements. Both the IRS and the states have begun to request documentation to support the deductions claimed. Please provide us with at least the value or dollar amount and an itemized list of what you donated (for EACH separate date that you donated). The Salvation Army and Goodwill websites have valuation guides to help you value your donated items. It is also recommended that you take a picture for your records. Finally, whenever possible, obtain a receipt from the organization.
- Request summary reports from your physicians and pharmacists to support your medical deductions claimed.

#### **BROADLY APPLICABLE FEDERAL HEALTH INSURANCE REPORTING**

If your health insurance coverage was through the Healthcare Exchange, at any time during the year of 2025, **WE MUST HAVE** the Form 1095-A that will be provided to you by the IRS or found on healthcare.gov in order to prepare and electronically file your tax return.

#### **DON'T FORGET TO PROVIDE YOUR IRS IP PIN**

An identity protection PIN (IP PIN) is a six-digit number that prevents someone else from filing a tax return using your Social Security number (SSN) or individual taxpayer identification number (ITIN). The IP PIN is known only to you and the IRS. It helps verify your identity when you file your electronic tax return.

If you have previously been issued an IRS IP PIN you will receive a new one each tax year. If an IP PIN has been issued in your name it will be required to electronically file your 2025 tax return. (IRS.gov)
